

Treasurer replacement

Trailer

Doug E had a long phone call Friday, Mar. 10, with Carl and the trailer that the club paid ½ of the \$3000 initial investment, was brought up. Since Carl titled the trailer in his name for insurance purposes, and completed necessary updates (brakes, tires, hydraulics) with his labor, and purchased required parts it is apparent to Carl that the trailer is his, even though the club had \$500 annually for M&O of the trailer.

Since the trailer is titled in Carl's name, the club doesn't appear to have any recourse to recover any of the previous investment in the trailer, unless Carl wishes to reimburse the club. No funds are to be disbursed for 2023 for trailer M&O.
